Dear Saint Pius X Catholic School Families,

With a proven foundation of 65 years of tradition and excellence, one of the foremost priorities of our school is delivering a challenging and inspiring academic experience, focused on the intellectual and spiritual development of every student. As you know, we are consistently dedicated to enriching the tradition and excellence of Saint Pius X Catholic School. In addition to our solid scholastic foundation, we are also tremendously proud of our social outreach endeavors, our broad range of extracurricular opportunities, and our committed and generous school community; and we are especially grateful for all of our students, Pre-K through 8th grade, who inspire us to provide challenging and innovative learning opportunities each and every day.

With financial guidance from our dedicated School Board, we aim to keep tuition affordable and in line with other Triad area Catholic and private schools while maintaining the rigorous, robust, and well-rounded principles of our curricular program. Very recently, our School Board members unanimously approved the budget and tuition rates for the upcoming school year. As we plan for 2020-2021, operating needs require us to increase tuition by \$22 per month for Catholic families and by \$32 per month for non-Catholic families. (This tuition increase is 2% lower than last year.) As always, families with multiple children attending Saint Pius X Catholic School will continue to receive discounted tuition. In addition to meeting the full range of rising costs of operation, the minor increase in tuition allows for a three percent raise for staff, as it is a top priority to attract and retain high quality educators to work in our school.

I am also very happy to announce that we are able to keep the Reregistration Fee at \$200 per student. (It was lowered last year from \$300 to \$200, and it is our plan to keep that fee as low as possible.) In addition, the Capital Fee will remain significantly reduced at \$400 per family. (Two years ago, this fee was \$796 per family.) This fee, assessed annually, spread over twelve months at \$33.33 per month, is used for capital repairs and maintenance for Saint Pius X School. Although there is a need for a slight increase in tuition, we are dedicated to keeping other fees as low as possible. Please see the tables included in the reregistration packet to see details of all new rates.

As a school, and with the backing of our parish community, we are pleased to have the ability to offer a top-notch, faith-based education at an affordable rate. It is our goal to continue this priority as we very much appreciate the sacrifices that many families make to ensure their children are given the opportunity to develop a strong Catholic academic foundation. Please know that tuition covers only 75% of the cost of a Saint Pius X education. The remaining 25% comes from Saint Pius X parish support, tuition subsidies from other parishes, fundraising initiatives, and generous donations from families, friends, and benefactors.

Included in this reregistration packet is a letter pertaining to our tuition assistance process. We use FACTS Grant & Aid Assessment to award tuition assistance for our families. Please refer to the letter which explains the process to file for tuition assistance should you have a need. As always, all families are welcome to apply for tuition assistance.

ST PIUS THE TENTH CATHOLIC PARISH MINISTRY INFORMATION



We no longer have paper forms to track stewardship participation. We are utilizing our new online database and church management software to more effectively manage and track ministry involvement. This allows for a more organic, ongoing process. This database, called *REALM*, makes it easier for parishioners to join ministries and also for our staff to verify involvement.

If you are seeking ministry involvement at St. Pius X parish, please follow the steps below.

- 1. Log into your *REALM* account through our parish website.
 - Go to: www.stpiusxnc.com
 - Click the *REALM* cloud logo in the top right from any page on our website.
 - Log in with your email and password.
 - Once you are logged in, please look on the left hand menu and select "Groups."
 - You will see your current ministry groups and class groups listed. Please verify that these are correct and nothing is missing. If you belong to a ministry that is not listed, please follow the next steps to join that group or contact your ministry leader and have them add you.

- You can then choose "Find Groups" under the Group level menu to browse our different ministry offerings.
- When you find one (or more!) that you are interested in joining, please click on the "+ Join" button at the top. The ministry leaders will be sent an email immediately and you will be contacted by them directly.
- 2. If you do not have a *REALM* account yet, you will need to request one.
 - Go to: www.stpiusxnc.com/realm
 - Fill out the form at the bottom of the page.
 - If you are a parishioner, you will receive an email "invitation" to join REALM.
 - If you are not a St. Pius X parishioner, you can still request a *REALM* log-in and keep up to date with parish events, programs, and even join ministries. You don't have to be a parishioner (or even Catholic) to participate in the life of our parish! Simply fill out the form on the account request page, and list your family's name in the comments box. A profile will be created for you and you will receive an email invitation to join *REALM*.
- 3. When our parish staff is verifying Stewardship Participation, the groups you are a member of in *REALM* will indicate your level of active participation at our parish.

Dear Saint Pius X School Parents,

FACTS Grant & Aid Assessment will be conducting the financial need analysis for Saint Pius X Catholic School for the upcoming 2020-2021 school year. Families applying for financial aid will need to complete an application and submit the necessary supporting documentation to FACTS Grant & Aid Assessment by **April 3, 2020**. Applicants can apply online by clicking the following FACTS link: https://online.factsmgt.com/signin/3RL4K.

Once an online application has been completed, the following information will need to be sent to FACTS to complete the application process:

- Copies of your most recent Federal tax forms including all supporting tax schedules
- Copies of your most recent W-2 forms for both you and your spouse
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF

All supporting documentation can be uploaded in pdf format online.
